No. 14/1/2015-SLG1(P.F.)/1080 - In exercise of the powers conferred by sub-section (2) of section 71 of the Punjab Municipal Corporation Act, 1976 (Punjab Act No. 42 of 1976) and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab Municipal Corporation Services (Recruitment and Conditions of Service) Rules, 1978, namely :-

RULES

1. (1) These rules may be called the Punjab Municipal Corporation Services (Recruitment and Conditions of Service) (Amendment) Rules, 2020.
- (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the said rules, for Appendix 'B', the following Appendix shall be substituted, namely:-

Provided further that in case any of the posts in the quota of promotion as specified in the aforesaid proviso for the members of the Punjab Service of Corporation Head Draftsmen and Punjab Service of Corporation Draftsmen is not fulfilled, then in such an eventuality the said post shall be filled in from amongst the members of the Punjab service of Corporation Head Draftsmen having an experience of working as such for a minimum period of Four years.
